"Administered by the US-based CFA Institute, the Chartered Financial Analyst® (CFA®) Program is a graduate-level and globally recognised program for investment specialists. The resulting professional credential/designation assures clients, employers, and colleagues that you as a charterholder, have mastered a rigorous finance and investment management curriculum; further that you are committed to the highest ethical standards in the profession. It is indeed, the most sought-after qualification by South African employers in the corporate finance and investments space.

Program Structure & Syllabus:

The CFA® Program is structured into 3 challenging levels:

- Level I (knowledge and understanding of investment tools and techniques);
- Level II (application of investment tools and techniques to asset valuation)&
- Level III (synthesis and evaluation of investment tools and techniques in the context of portfolio management and wealth planning).

The above 3 levels are underpinned by a network of progressively challenging Learning Outcome Statements (LOSs), founded on 10 syllabus topic areas:

- 1. Ethics & Professional Standards;
- 2. Quantitative Methods;
- Economics;
- 4. Financial Statement Analysis;
- 5. Corporate Finance;
- 6. Equity Investments;
- 7. Fixed Income;
- 8. Derivatives:
- 9. Alternative Investments; and
- 10. Portfolio Management and Wealth Planning.

Exam Format & Schedules:

All CFA® Exams are computer-based, under the following scheduling windows:

For Level I: 4 times a year: February, May, August and November;

For Level II: 3 times a year: May August/September, and November 2024, and

For Level III: Twice a year; February and August/September.

Level I exams will be 4 hours and 30 minutes, split into 2.25 hour sessions. Level II and III will be 4 hours and 24 minutes, split into two equal sessions of 2 hours and 12 minutes, with an optional break in-between.

Exemptions & Eligibility:

Irrespective of your prior qualification and/or experience, you cannot apply for exemption from any Level of the CFA® Program. To be eligible to start at Level I, you must either:

- · Hold a bachelor's (or equivalent) degree, or
- Be in the final year of your bachelor's (or equivalent) degree, and/or
- Have four years of work experience (not necessarily investment related).

<u>Please note:</u> Although four years of work experience which is not necessarily-invested related will grant you eligibility, you will be required to submit three years of relevant work experience before being accorded the CFA Charter. This relevant experience you can gain before, during or after completing all the relevant CFA exams."


Study Options, Packages & Fees

Choose between 3 study packages (Tuition & Exam Preparation Package (TEPP) -Evenings & Weekends; Exam Preparation Only Package (EPOP) -Evenings & Weekends; or Livestream Interactive+ (Online)). You have the flexibility to attend our Full course (comprising of all 5 books/modules -at each level), and/or our exam preparation classes. For example, selecting TEPP will allow you to attend all 50 classes, covering all 5 books/modules (including 4 exam revision practice workshops); or, you can choose to only pay for and attend the scheduled 2-8 classes (including 4 revisions classes) that will be covering exam preparation only.
