Internal Assessment	CharterQuest will conduct internal assessments by means of knowledge and practical assessment activities
Work Experience	During the 12-month program, the learner obtains work experience relevant to the required work experience module in the curriculum. The employer is responsible to ensure that work experience must be assessed by a Registered Assessor.
Statement of Results (SoR)	Upon successful completion of all four modules, CharterQuest issues a Statement of Results to the candidate based on the Knowledge, Practical and Work Experience. This SoR will give the candidate access to the qualifying assessment - External Integrated Summative Assessment (EISA).
External Assessment	On completion of the program, the candidate must apply to the Institute of Risk Management South Africa (IRMSA) for the External Integrated Summative Assessment (EISA).
Certification	Upon successful completion of the External Summative Assessment, IRMSA will recommend candidates to the Quality Council for Trades and Occupations (QCTO) for certification.
